PREAMBLE:

In the reference 1st cited, the Karpagam Charity Trust, Coimbatore has obtained Government Order from Health and Family Welfare Department, Chennai, to start B.Pharm. Degree Course in the name and style as Karpagam College of Pharmacy, Othakkalmandapam Post, Coimbatore – 641 032 with an annual intake of 60 seats from the academic year 2006-2007.

2. In the reference 2nd cited, the University had granted the Order of Provisional Affiliation to Karpagam College of Pharmacy, Othakkalmandapam Post, Coimbatore – 641 032 for starting the B.Pharm. Degree Course with an annual intake of 60 seats from the Academic Year 2006-2007.

3. In the reference 3rd cited, the Karpagam Charity Trust, Coimbatore has obtained Permission from the Government of Tamil Nadu for the enhancement of seats in B.Pharmacy course from 60 to 100 from the academic year 2020 – 2021.

4. In the reference 4th cited, the University had granted Continuance of Provisional Affiliation order for 60 seats and Permission for increase in annual intake from 60 to 100 seats to Karpagam College of Pharmacy, Coimbatore for the academic year 2020 – 2021.

5. In the reference 5th cited, the University had granted the Provisional Affiliation order to Karpagam College of Pharmacy, Othakkalmandapam Post, Coimbatore – 641 032 for starting I year M.Pharm. Degree course from the Academic Year 2010 – 2011.

6. In the reference 6th cited, the University has granted the Provisional Affiliation order to Karpagam College of Pharmacy, Othakkalmandapam Post, Coimbatore – 641 032 for starting the Pharm.D. course from the Academic Year 2015 – 2016.

7. In the reference 7th cited, the University had granted the order of Continuance of Provisional Affiliation to Karpagam College of Pharmacy, Coimbatore for conducting M.Pharm. & Pharm.D courses for the Academic Year 2020-2021.

8. In the reference 8th & 9th cited, the Pharmacy Council of India, New Delhi (PCI) has granted approval for the academic years 2021-2022 and 2022-2023 to conduct B.Pharm., M.Pharm. & Pharm.D Courses at Karpagam College of Pharmacy, Coimbatore.

9. Based on the resolution No. 51, passed at the 287th Governing Council meeting held on 22.12.2021, Institutions have been instructed to upload the necessary documents in the Affiliation module of CMS 2. Further, Virtual Inspection has been conducted on 28.03.23 to assess and report on the infrastructural, teaching and other facilities available at Karpagam College of Pharmacy, Coimbatore for considering the grant of Continuance of Provisional Affiliation for conducting B.Pharm., M.Pharm. & Pharm.D courses for the academic year 2021-2022.

10. In the resolution No. 42, passed at the 292nd Governing Council meeting held on 03.08.2022, it was resolved to grant orders of Continuance of Provisional Affiliation / Conditional Continuance of Provisional Affiliation for the academic year 2022-2023 based on data submitted in the Affiliation portal and the virtual inspection conducted for the academic year 2021-2022.

11. The Seat Matrix has been informed to the Selection committee for the academic years 2021-2022 and 2022-2023 in respect of B.Pharm. & M.Pharm. Degree courses.

12. The said institution has remitted the requisite fee for the academic years 2021-2022 and 2022-2023.

ORDER:

In pursuance to the Resolution passed by the Governing Council, inspection report submitted by the Inspection commission, data uploaded in the CMS2 portal, approval of the Pharmacy Council of India and on receipt of requisite fee for the academic years 2021-2022 and 2022-2023, the University grants Continuance of Provisional Affiliation to Karpagam College of Pharmacy, Coimbatore for conducting B.Pharm., M.Pharm. & Pharm.D Courses for the academic years 2021-2022 and 2022-2023, subject to the following conditions:

i) To fulfill all the requirements (infrastructural, teaching and other facilities available) in the CMS2.0 portal;

ii) To rectify any other deficiencies pointed out in the report of the Inspection Commission and data submitted in the portal;

iii) To abide the prescribed Rules / Guidelines of the Statutory bodies / Government of Tamil Nadu and the Affiliation Statutes of the Tamil Nadu Dr. M.G.R. Medical University, Chennai, imposed from time to time;

iv) The University may conduct inspection to verify the above if required and

v) The usual conditions already intimated in the Provisional Affiliation orders of this University.

15. The admission procedure as laid down in the G.O. of Health and Family Welfare Department, Chennai should be followed strictly. Any admission made over and above will not be permissible on any account.

16. The approval from relevant Council should be produced every year to consider further Continuance of Provisional Affiliation.

17. Any other condition which the University considers necessary to impose from time to time should be followed strictly.

Degree Course with two branches Pharmaceutics and Pharmacology with an annual intake of 18 seats each from the Academic Year 2010 - 2011.

2. In the reference 2nd cited, the University had granted the Continuance of Provisional Affiliation to Karpagam College of Pharmacy, Coimbatore for conducting M.Pharm. Degree Course for the academic year 2020-2021.

3. In the reference 3rd cited, the Principal, Karpagam College of Pharmacy, Coimbatore has requested the Letter of Consent of Affiliation to start Pharmaceutical Analysis branch in M.Pharm. Degree course for the academic year 2021 -2022 to obtain approval from the Pharmacy Council of India, New Delhi.

4. Based on the request of the Principal, an Inspection was conducted on 27.04.2021 to verify the infrastructural, teaching and other facilities available for the conduct of Pharm. Analysis branch in M.Pharm. Degree course. On scrutiny of the Inspection report, revealed certain deficiencies. The said institution was directed to rectify the deficiencies and furnish compliance. The said institution submitted the compliance report and the connected documents on 02.07.2021 and 12.08.2021. Consequently, Letter of Consent of Affiliation was granted on 03.09.2021.

5. In the reference 5th cited, the Principal, Karpagam College of Pharmacy, Coimbatore has requested for grant of Provisional Affiliation to start Pharmaceutical Analysis branch in M.Pharm. Degree course along with the approval of the Pharmacy Council of India (PCI), New Delhi for the academic year 2022-2023.

6. In the reference 6th cited, the Pharmacy Council of India(PCI), New Delhi has granted approval to Karpagam College of Pharmacy, Coimbatore for starting of Pharm. Analysis branch in M.Pharm. Degree course with an annual intake of 15 seats for the academic year 2022-2023.

7. In the reference 8th cited, an inspection was conducted on 10.11.2022 for grant of Provisional Affiliation and the Inspection Commission constituted has submitted its report. On scrutiny of the Inspection report, revealed certain deficiencies. The said institution was directed to rectify the deficiencies and furnish compliance. The said institution submitted the compliance report and the connected documents on 28.12.2022.

8. In the reference 11th cited, the Principal, Karpagam College of Pharmacy, Coimbatore requested for change of academic year from 2022-2023 to 2023-2024, since the cutoff date for the academic year was already over on 30.12.2022.

9. In the reference 12th cited, the Principal, Karpagam College of Pharmacy, Coimbatore has remitted the requisite fee for the grant of Provisional Affiliation for starting Pharmaceutical Analysis in M.Pharm. Degree course for the academic year 2023-2024.

10. In the reference 13th cited, the Pharmacy Council of India in its 391 EC dated 05.03.2023, has decided to extend the approval of existing course as approved by PCI as per approved intake in 2022-2023 for the academic year 2023-2024.

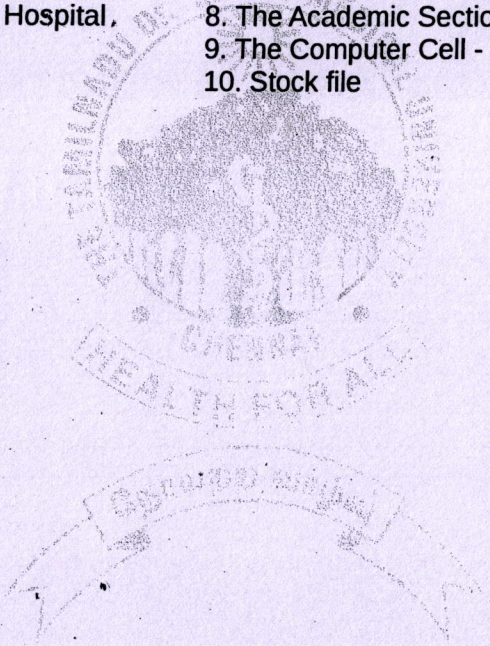

ORDER :
